Italy downgrades PV module exports



Overview

Since August 28, 2025, Decree “MASE No. 220/2025” has been in force, providing a special procedure for photovoltaic systems with capacity over 1 MW using “non-Chinese” components. Can agrivoltaics be expropriated in Italy?
