Comoros Customs levies import duties, including import duties (with rates of 20%, 15%, 5%, and zero duty), and consumption tax (with a rate of 10%). As of early 2015, Comoros Customs implemented a single import duty on rice, gasopne, and diesel. The rates are \$0.11 per kg for ordinary rice, \$0.42.
